AWARDING OF MAHAPOLA HIGHER EDUCATION SCHOLARSHIPS - 2021/2022.

- 01. I am pleased to inform that you have been selected to award a general scholarship by Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund Board as per the recommendation of your Educational Institute.
- (i) This scholarship is awarded to you with the great objective of providing an effective assistance for pursuing your higher education activities continuously and diligently without financial difficulties. Accordingly, as per the recommendation of the Institute, you are assigned to it and will be paid Rs.2,500/- monthly installments subject to a maximum of 09 installments per one academic year during the period of conducting the course within the prescribed academic duration of the course that you have been selected, by the institute. (The installment amount from April 2025 will be Rs.3,750/-)(You should fill Annexure 02 to submit your bank account details.)
 - (ii) Due to engage in an employment, on your will or due to any other reason or at any time, you can make a request to discontinue your scholarship.
- The list of conditions relevant to this scholarship awarding is attached herewith. Please read those conditions carefully. You will be subjected to those conditions after accepting the scholarship.
- 04. You will be subjected to the rules and regulations that may be imposed in future with regard to your scholarship by Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund and authorities of the Education Institute.
- O5. Changes of your course, registration number etc. should be informed to the Institute without delay. Your Scholarship Awarding Number should be mentioned in future correspondence as way.

 After the commencing of your academic activities, all the correspondence should be done through the Head of your institute.
- O6. As per the norms of the Mahapola scholarship awarding, you should personally accept the scholarship in order to be eligible for that. If not, your scholarship will be cancelled.
- 07. I wish you all the best in your studies.

CONDITIONS RELAVANT TO MAHAPOLA SCHOLARSHP AWARDING & INSTALLMENTS PAYMENTS

The following requirements and conditions are applicable to be entitled for the Mahapola Scholarship and to receive Scholarship installment payments on behalf of the said scholarship within the academic duration.

- 1. Scholarship installments will be paid monthly as per the recommendation made by the institute based on the progress made by the scholarship recipient on the studies for which the scholarship was awarded.
 - 1.1 For scholarships, scholarship installments will be paid subject to a maximum of 09 installments per an academic year.
 - 1.2 Student should be engaged in full time studies to entitled to the Scholarship payments and no payments will be made for those who do not participate in full time studies.
 - 1.3 It is required to attend, properly, for the lectures, tutorial classes, and practical classes prescribed for the course and to have an 80% attendance. In situation contradictory to that, scholarship payments will be suspended in accordance with the recommendation made by the university in this regard.
 - 1.4 Only one installment per month during the period of conducting the course will be paid to the scholarship recipient by the education Institute.
 - 1.5 Scholarship installments should be collected regularly and uncollected installments will be treated as unneeded and abandoned installments. Such installments will not be re-paid unless the proper justification and recommendation made by the Institute.
 - 1.6 The Institute recommends the names of scholarship recipients for paying the scholarship installments, if it is not recommended so, it should be inquired from the institute in that regard.
 - 1.7 After acceptance of this scholarship, you are not permitted to receive any other scholarship or bursary connected with this same course of studies or any other course of studies. In case the you become eligible for another such scholarship you will have the option either to retain the former scholarship only or to have the former scholarship cancelled and to receive the new scholarship. In such cases, the student should notify this office immediately.
- 2. The **Scholarship will be cancelled** in below mentioned situations. Appeals submitted in that regard also will not be considered.
 - i. Non attending the course.
 - ii. Long term absence to the course.
 - iii. Failure in annual exams.
 - iv. Abandonment of the study course.
 - v. Class suspension due to disciplinary matters
 - vi. Receiving punishments with regard to ragging.
 - vii. At an instance where student has been punished after a disciplinary inquiry conducted by the institute for offences on act of misconduct, delinquency or abuse or when punished by a court for other offences.
 - viii. Receiving punishments for damaging institute or public property.
 - ix. The reasons of engaging in a business, service or employment for generating income will be caused for the discontinuance of the scholarship installments and eligibility.
 - 3. The decision of the Lalith Athulathmudali Mahapola Higher Education Scholarship Trust Fund regarding scholarships or scholarship installments will be treated final.
